

Federal legislation Alert!

Call your legislators and say NO to HR2492!

The Humane Society of the United States (HSUS) and Humane Society Legislative Fund has arranged for the introduction of the Animal Fighting Spectator Prohibition Act of 2011. Tom Marino (Republican from PA) and Betty Sutton (Democrat from OH) have subsided to the communist type agenda of the HSUS. They seek to manufacture criminal activity at the whim of HSUS. They seek to stifle the right to assemble. Property rights are ignored. They tell you where you can take your children and will imprison you if their dictations are not followed.
